General conditions for events at the ZHAW Life Sciences and Facility Management

1 General information

The ZHAW Life Sciences and Facility Management offers a variety of events. The school is responsible for organizing and implementing these events. The following admission and participation conditions apply to all events taking place outside of teaching and further education. The Zurich University of Applied Sciences (ZHAW) reserves the right to make amendments to these terms as required.

2 Admission

Events at the ZHAW Life Sciences and Facility Management are open to anyone who is interested, in accordance with the applicable event description. Differing admission requirements may apply in some situations, which are specified in the respective descriptions for those events. Participation in all events is contingent upon full payment of the associated costs before the event is held.

3 Registration

When registering, the participant is required to provide all necessary information for the registration process completely and truthfully. Both written and online registrations are binding. By registering, the participant confirms that they have read and accepted the terms and conditions of admission and participation, as well as the conditions of the event in accordance with the event description. The number of participants that may participate in any event is limited. Unless otherwise stated in the event description, all applications are considered in the order that they are received. Acceptance of registrations received after the registration deadline is at the discretion of the event organisers.

4 Prices and payment

The costs incurred for an event and the services included therein are included in the event description. Normally, the cost of participation is paid in full with a credit card when registering. Registration is only valid once the payment has been made.

5 Cancellation of registration, no-shows or withdrawal from participation

Withdrawal from an event must be done in writing. Until the registration deadline has passed, withdrawing from an event will not incur any costs. After this period, however, or in the case of a no-show or cancellation, the costs will be forfeited in full. Any variations to this are specified in the event description.
